## An Effective Due Diligence Process

To obtain full, transparent and true information regarding an investment manager that will enable an investor to make a well informed decision.



## Operational Risk

Risk of loss resulting from inadequate or failed internal processes, people, systems or from external events.

## Sources of Operational Risk

Sources	Definition	Mitigating the risk
Errors	Mistakes made in the process of executing the investment strategy.	Prevent and detect errors by ensuring well-designed and implemented operational systems.
Agency Conflict	Intentional actions of the firm's employees that are contrary to the investor's best interests.	Controls over conflict of interest (i.e. compensation, outside business activities, personal trading, code of ethics, etc.)
Fraud	Intentional, self-serving and deceptive behavior in the firm's activities that is harmful to the investor.	Segregation of duties between the portfolio management functions from the accounting, performance and valuation processes.



Prior to any allocation, investors should mandate a due diligence on all types of investment managers that include:

- Broker-Dealer
- Investment Advisors
- Investment Counsel/Portfolio Managers
- Mutual Funds
- Hedge Funds
- Private Equity

- Report the results identifying the strengths and weaknesses
- Continued Monitoring

- Due Diligence Questionnaire

- Service provider agreements
- Manager's policies

## Due Diligence Investment Manager Review

On-site reviews of investment manager's operations with focus on that include:

- Investment Management Company
- Product Offering
- List of Service Providers
- Portfolio Objective and Strategy
- Valuation Controls
- Performance Appraisal and Controls
- Risk Management Controls
- Controls over assets, trading and net asset value
- Information Technology
- Compliance



## Due Diligence Review of Service Provider

Reviews of services provider's services:

- Agreements
- Servicing
- Systems and Staffing
- Control Environment
- Compliance Environment

## Due Diligence – Detailed and Summarized Report

Report will provide the client with:

- Executive summary highlighting the strengths and weaknesses
- Detailed Report providing in-depth analysis of the investment manager's investment philosophy and operations
- Recommendations on any improvements

## Due Diligence – Continued Monitoring

Continued Monitoring throughout the relationship that includes reviewing and identifying operational and business changes to the investment manager's operations. Areas will include:

- Changes to investment manager's corporate structure, staffing, product offering, service providers and control environment
- Performance Appraisal reviews, including marketing material
- Compliance breaches and regulatory sanctions against the investment manager
- Review of audited financial statements
